

# BrightQ Customer Identification Form

## Step 1

Collect certified identification from all individual applicants. Mortgagors & directors of corporate applicants or trustees, corporate mortgagors and individuals acting as a trustee or in possession of a power of attorney to sign a mortgage.

A separate form should be completed for each individual (natural person).

Interview via video conference and capture a screenshot of the individual holding the original identity documents.
